Painting of 11 townhomes on Westkendal was scheduled to start May 26th. With all the rain we've been having, it may take longer than anticipated to complete.

The pools officially opened May 22. Again, rain has played a role in limiting usage. You don't have to see lightening for there to be potential danger. If you hear thunder, you must clear the entire pool area immediately. We have several wonderful pool attendants again this year. Part of their many duties is to check your patches. They can also sell them to you for \$2 each. There is a limit of 10 per household. They will also check their list to be sure there is a lease on file for tenants. If you are not sure we have a copy of your lease, please call the helpline. We will verify that we have a lease on file.

With all the rain, we are likely to have a bumper crop of mosquitoes. Dump standing water immediately and clear out any wet leaves. It only takes a little standing water for mosquitoes to thrive. Drain grills, potted plants, old tires, and especially gutters. Gutters make a great breeding ground. An accumulation of leaves and debris can also make them heavy to the point of falling down. Some of you have mini gardens growing in your gutters. Debris can also clog the downspout. Get in the habit of having your gutters cleaned twice a year. If any of you offer that service, post a notice on the clubhouse bulletin board. Stir bird baths at least every two days. Don't let that water sit. Also, be on the lookout for termites in your garage and around your house.

There will be a Quarterly meeting Sunday June 14th at 2:00 PM. The agenda will be going out shortly.
